## Services, Fees and Policies

### 20 minute consultation Holistic Homeopathic Healing: Complementary

<b>Initial consultation:</b> (Up to 2 hours)	\$350
<b>Initial consultation:</b> (child 5 and under - 1 hour)	\$180
<b>Follow up consultation:</b> (Up to 60 minutes)	\$130
<b>Therapeutic Focus consultation,</b> new clients: (1 hour)	\$130
<b>Acute consultation,</b> existing clients only: (15 minutes)	\$ 45
<b>Acute Consultation,</b> New Clients: (1/2 hour)	\$ 65

### Initial 6-month Wellness Package— 7 hours of homeopathic care includes:

#### Initial consultation and 5 Follow-ups

Payment in full at first appointment:	(\$200 savings)	\$800
Payment in installments:	(\$100 savings)	\$900

### Continuing 6-month Wellness Package—6 hours of homeopathic care includes:

#### 6 monthly Follow up appointments (1 hour each)

Payment in full at first appointment:	(\$180 savings)	\$600
Payment in installments:	(\$ 80 savings)	\$700

### Continuing 12-month Wellness Package—4 hours of homeopathic care includes:

#### 4 Quarterly Follow up appointments (1 hour each)

Payment in full at first appointment:	(\$100 savings)	\$420
Payment in installments (\$118.75 each):	(\$ 45 savings)	\$475

### Interim support for Package clients:

- ◆ no charge for brief phone calls of 5 minutes.
- ◆ acute appointment (15 minutes), can be scheduled
- ◆ The office is closed after 6 pm on weeknights and on weekends
- ◆ If you have an urgent matter, you may call until 9 pm. There will always be a consult fee for these calls.

### Telehealth: Appointments by telephone, or by video (Zoom)

**Payment:** by check, cash or other form of payment (i.e. Venmo, Zelle: phone number or email) is expected at the time of your visit or according to your payment plan. Payment plan clients are asked to keep a credit card on file.

**Insurance/HSA/FSA:** We don't file insurance or reimbursement forms, but can provide an account statement if the client wants to file for reimbursement with an HSA or FSA, which reimburse payments with pre-tax funds.

**Travel fee if applicable:** \$25 per 15 minutes will be capped at \$50.

**Phone, email, text:** Time accumulates with each call, email and/or text over 15 minutes, when it reaches 1 hour, you will be charged the regular hourly rate.

**Cancellations:** If it is necessary to cancel/reschedule an appointment, please notify at least 24 hours in advance. Missed appointments or late cancellations will be charged the full fee.
