APPOINTMENTS AND FEES:

Regular fee for Initial Consultations (2 hours):	\$350

WELLNESS PACKAGES:

6-month Holistic Homeopathic Care (7+ hours) includes:

- The *initial consultation*--the foundation of quality homeopathic care. (2 hours)
- 5 *Follow-up appointments*--the essential means of assessing progress. Approximately every 4-6 weeks.

Up to 15 min. per communication. If longer than 15 minutes, time will accumulate, when it reaches 1 hour, you will be charged an hourly rate of \$130, or if 6 mo. is over, a pro-rated amount.

Payment in full at first appointment: \$800
Payment in installments: \$900

- 6 appointments--the essential means of assessing progress. Approximately every 4-6 weeks.

INTERIM SUPPORT

FOLLOW-UP APPOINTMENTS

In the first few days after taking your remedy, you may experience some symptoms. It is important that you email me at laynhoffman@gmail.com or call me on my cell phone at 845-558-4293 in the following cases:

- If you develop any disturbing symptoms
- If your present symptoms worsen
- If you need to discuss any aspect of your treatment

After your first appointment, and when you begin taking a remedy, we will set up an appointment for 4-6 weeks later to discuss how you have been feeling. Follow-up consultations are an essential time for evaluating the effect of the remedy and your progress, and for making any necessary adjustments.

Payment: by check, cash or credit card or other form of payment (i.e. paypal) is expected at the time of your visit or according to your payment plan. Payment plan clients are asked to keep a credit card on file.

Insurance/HSA/FSA: We don't file insurance or reimbursement forms, but can provide an account statement if the client wants to file for reimbursement with an HSA or FSA, which reimburse payments with pre-tax funds.

Travel fee if applicable: \$25 per 15 minutes will be capped at \$50.

Phone, email, text: Time accumulates with each call, email and/or text, when it reaches 1 hour, you will be charged the regular hourly rate.

Cancellations: If it is necessary to cancel/reschedule an appointment, please notify at least 24 hours in advance. Missed appointments or late cancellations will be charged a fee of \$100.
